## What we need from you:

- Provide an electronic copy (PDF format) of drawing stamped and signed by Registered Civil Engineer to include the following:
  - A site plan drawn to scale showing:
  - Boring/Potholing locations in reference to centerline of streets. Boring/Potholing shall be set a minimum of 2' off the face of the gutter. Boring shall be a minimum 5' clear from the edge of existing storm drain pipes and sewer pipes (including sewer laterals), and a minimum 2' clear from other utilities typical. No drilling/potholing is permitted in the concrete gutter area, bus pad area, and sidewalk area.
  - Property lines, curbs, gutters, utility lines, sewer lines (including sewer laterals), and storm drains. Related City's maps are available in 1149 S. Broadway, Suite B-10, Tel: (213) 847-0700 or <u>http://navigatela.lacity.org</u>
